\*For formal makeup services, **please arrive with clean skin and no eye makeup.** Please inform your makeup artist of any skin allergies or irritants. If you prefer to bring any of your own products, we are happy to use them for your look. There is a 10% discount for any makeup purchased during your trial. **\*\*\*We prefer you to bring your own mascara but we always have it available for use including waterproof and non-waterproof.**

Please note: A Bridal Hair and A Bridal Makeup Trial is **required** to book services with Daisy's Salon. Trials are where we discuss your beauty vision for your wedding day, and jot down any important information we need to make sure the day-of runs seamlessly.

Trials also ensure our team will be running smoothly and proficiently.

Lastly, this contract is required to hold your wedding date and to book services. When we receive your signed contract, 50% of the services booked will be charged as a non-refundable deposit will be charged to the card given below.

This amount will be deducted when final payment is made.

By signing and submitting this contract, you agree that final changes to any appointment will be made 30 days prior to the wedding.

Any appointment cancellations made within the 30 days of wedding will be charged 100% in full. There will be 20% gratuity applied to all services.

There is a \$100 fee for services provided on Sundays, holidays, and services after normal business hours.
